RULES AND INFORMATION

The A.S.D. ARIES COMO ATHLETIC TEAM organises the **non-competitive 5 km road running event**, in cooperation with the Municipalities of Como and Cernobbio.

PROGRAMME - TIMETABLE

The event will take place on 01.12.2024

Meeting point: from **7:40 a.m.**, **Como, Villa Olmo park**

Start: approx. **8:40 a.m.**, **Como, Villa Olmo park**

Arrival at the same starting point.

RACE COURSE

The 5 km non-competitive race, included in the event Synlab Como Lake Half Marathon, is a road running event that will take place on completely asphalted municipal and provincial roads. The authorities in charge (Province of Como and Prefecture) will ensure the total/partial closure to traffic in the Como - Cernobbio section (until the turnaround at approx. 2.5 km).

Since this is an outward/return route, participants must keep to the left side on the outward journey (lake on the right) and to the right side on the return journey (lake on the left).

Adequate security will be provided throughout the sections of the race course without pavement and at crossings.

The event will cross the municipalities of Como and Cernobbio.

PARTICIPATION REQUIREMENTS

All those who will be 18 years old or over on 1 December 2024 will be eligible to participate.

REGISTRATION DEADLINE

Registrations will close on 28.11.2024 at 23:59.

The organising committee reserves the right to close registrations early **after reaching 300 participants.**

Should the limit of 300 registrations not be reached by 28.11.2024, the organising committee reserves the right to **re-open registrations on Saturday 30 and Sunday 01 dicembre 2024. Late registrations will cost 20.- € plus 5 € for administrative fees.**

N.B. athletes not collecting their bib for personal grounds will not have the right to the refund of the registration fee. Registrations may however be postponed to the 2025 edition via a dedicated request to iscrizioni@ariescomo.it (such request must be submitted by **28 November 2024 at 23.59**).

It is only possible to postpone to the following edition once.

REGISTRATION TRANSFER

Athletes who have regularly registered but are unable to attend the race may transfer their registration to another athlete meeting the participation requirements under this Regulation. It is mandatory to communicate the change by **Thursday 28.11.2024** at: synlabcomolake@evodata.it. The transfer will involve a **5 €** (five/00) administrative fee, which will need to be paid when the athlete will collect the bib.

BIB COLLECTION

In accordance with the health regulations in force on the day of the race, race bibs may be collected **on Saturday 30 November 2024 from 14.00 to 19.00 or on Sunday 01 December 2024 from 06.30 to 08.00 AM in Como at the Villa Olmo park**. Any further requirements (including any derogations linked to any FIGC calendar requirements) will be posted in due course **on the website and social media channels**. The bib is strictly personal, it cannot be given away and cannot be damaged. Those found liable will be disqualified. The bib must be appropriately pinned on the chest during the race.

Third parties may collect the bib as long as they present a valid authorisation form signed by the delegating person and a copy of their ID.

SECURITY SERVICE

The Organising Committee declares that it has followed the procedures and instructions regarding Safety & Security and will comply with all the prescriptions that the competent Authorities may require in order to authorise the competition, with particular reference to Art. 32 of the 'Rules for the organisation of events' regarding safety, as specified in the 'Safety Plan for public events' by the Comitato Regionale Lombardo.

The Organising Committee has signed a Civil Liability insurance policy for damages to Third Parties resulting from all activities linked to the event.

TIMING AND RANKINGS

EvoData SRL will be in charge of the timings and of drawing up rankings exclusively for statistical purposes.

MAXIMUM TIME

The time limit is **1 hour 00 minutes**.

Beyond this time, the Organising Committee will no longer be able to guarantee services on the course and declines all responsibility.

FINAL WARNINGS

The organising committee reserves the right to amend these Regulations, at any moment, for any reasons it will consider adequate for the organisation of the race, or for public security grounds as requested by the local administration and/or by the Police officials. Any additional documentation containing the essential information to participate in the race will be circulated together with the bib.

CHANGING ROOMS - SHOWERS – DEPOSIT FOR BAGS

Toilets will be provided inside the stadium.

Unless otherwise indicated, showers and changing rooms will be provided, except in case of force majeure circumstances, **not dependent on the organising committee**, which will be duly communicated in advance.

There will also be an unattended bag storage service inside the stadium. The organising committee declines any responsibility in case of theft/loss.

REFRESHMENTS

Refreshments will be available along the race course in accordance with the regulations.

There will be a FINAL refreshment point next to the start/finish.

The event adheres to the “I don't throw my rubbish” campaign: those caught abandoning material and/or rubbish on the route, outside the established points, will be **disqualified**.
